OWNERSHIP

DELIVERY & DISPATCH

If not differently agreed, all equipment will be delivered Ex Works at manufacturer's shipping point. Delivery periods are not binding unless the seller has expressly given a confirmation in writing. The delivery term written in our offer and/or confirmation and /or pro-forma invoice is intended the day that the goods leaving the stock. In case of unforeseen delivery impediments such as act of God, strike, interruption of operations in our own company or in our suppliers company or transport problems etc..., the seller may not be held responsible for damages caused. In case of carriage paid, dispatch is made within the sellers discretion and without any guarantee of the cheapest way of dispatch. Insurance is obliged and affected at buyer expense. All consignments including possible returns are at the buyers risk and expenses. WARRANTY

The standard TEM's warranty lasts 24 months from shipping date (if not differently stated) and covers all parts and labour required to repair any equipment or replace the faulty components. The warranty will be carried out free of charges for the customers. The warranty is valid at TEM's facilities in Binasco (MI) - Italy. Only the freight costs, including related Customs Duties, to and from TEM facilities, are at customers' charge. It is compulsory to contact the Sales Department before shipping any equipment or part under the Warranty Terms, in order to agree the correct procedure in advance. The warranty is not valid for any fault related to external causes such as spikes on the mains or lightning, or in case the instructions and advices as described in the Users Manuals are not strictly followed. If any malfunctioning is discovered during the warranty period, TEM Technical Support Department has to be contacted before attempting to repair or replace any part and to make any adjustment. In case this precaution won't be taken, the warranty decays. TEM Sales or Technical Support Departments have to be notified within a reasonable period of time from the discovery of the fault. A failure written report should be always sent to TEM, duly signed by the technician in charge of the maintenance, and a copy has always to travel with the goods. In case the precautions as carefully listed in the Users Manual will not strictly observed, the warranty is invalid. Semiconductors, power supplies, blowers, air filters, are not included in the warranty. Spares and softwares will be available for period of 10 years. Any modification to the above warranty terms has to be stated in written.
